### • **Designed for Quick Touch-Up Spotting**

One of the most frustrating things a professional cleaner faces? When an item that has been cleaned picks up a stain after it has been processed. A stray greasy fingerprint or a mark from brushing up against a piece of equipment can leave an oily stain, undoing the work already done. This can mean incurring the extra time and cost of a re-clean. **Touch-Up** provides a different way to help you avoid having to reclean these items; its special aerosol formula quickly dries to a powder, absorbing stains and lifting them away from garment fibers, without need for flushing or recleaning.

### • **Removes Grease, Oil, & Other Dry-Side Stains**

Can be used before or after cleaning, pre-spotting or post-spotting, to effectively and quickly remove a wide array of greasy, oily stains like cosmetics, food oils, machine oils and other dry-side stains, without need for flushing or recleaning.

### • **Removes & Helps Prevent Spotting Rings & Circles**

Use **Touch-Up** for pre-spotting or post-spotting to remove the circles or spotting-rings that can be caused by previous stain removal procedures.

### • **VOC Compliant all 50 U.S. States, including California**

**Touch-Up** contains no chlorinated solvents and provides a way to perform fast dry-side stain removal without relying on volatile liquids. It can be used in California and other areas which prohibit high-volatility stain removal products.

No need to worry about using stain removal products in the wrong order and no need to use tamping, scraping or other techniques that can damage garment fibers when performed by less experienced spotters.

## Use Instructions for Touch-Up

*If colorfastness is questionable, test fabric in a hidden area.*

- When the stained area is completely dry: **SHAKE CAN WELL.** Spray lightly onto fabric stain in a circular motion.
- **If compressed air is available:** Make sure there is no moisture in hose. Very gently, aim air stream at treated stain from a distance of about 1.5 ft.-2 ft. (45-60 cm). Gently blow treated area until a white powder appears. For best results, let powder sit to allow time for the stain to rise to the top of powder. With a heavy force of air, blow out remaining residue away from user. Do not inhale powder. Repeat as needed. Air dry with compressed air, as needed.
- **If compressed air is not available:** For best results, wait 5-10 minutes until the white powder appears. Allow time for the stain to rise to the top of powder. Brush or shake out residue away from user. Do not inhale powder. Repeat as needed.

### How to Order Touch-Up

**Touch-Up** is sold by authorized Street's distributors. Order from your local distributor in single 12-oz (340 g) cans, or in boxes of twelve 12-oz cans.

Before using any chemical product, review the Safety Data Sheet (SDS) for safe handling and proper disposal. For professional drycleaning, wetcleaning and laundry use only.
