## **TIGER Use Instructions**

For professional drycleaning use only. Before using any chemical product, review the Safety Data Sheet (SDS) for safe handling and proper disposal.

## Load Process (Injection) Use

- Although not required, for best results, a 3-minute batch prewash is recommended to remove loose soil, grease, bleeding dyes, and stain removal additives.
- After 1 minute of fill, and once garments are wet with solvent, inject **TIGER** either into the wheel, fill line, or button trap.
- For optimum sizing, and soil and stain removal, inject TIGER at a rate of 4 oz per 10 lbs (or 260 mL per 10 kg) of garments.
- Run 5 minutes with circulating solvents, bypassing filter (milling) to release soil.
- Run an additional 5 to 10 minutes on filter to remove released soil.

**NOTE**: Fragile garments should be run 3 minutes on batch (or milling) then 5 minutes on filter to reduce mechanical action. Do not prewash.

<u>NOTE</u>: A 5-minute pre-rinse to the still is recommended for heavy soil or potential dye bleed items.

<u>NOTE</u>: **TIGER** does not contain water. Addition of small amounts of water (by injection or prespotting) can optimize results in dry climates. **TIGER** will handle limited amounts of additional moisture when used at the recommended dosage.

TIGER Contains Perchloroethylene CAS #127-18-4. Drycleaning equipment using perchloroethylene generates process waste streams that contain perchloroethylene thereby rendering them hazardous wastes under various Federal, state and local laws. These hazardous wastes include, but are not limited to, spent filter cartridges, filter powder, distillation residues and contact water. All disposals of these wastes must be done in accordance with Federal, state and local regulations. Regulations may vary in different locations. Waste characterization and compliance with disposal regulations are the responsibilities of the waste generator. In no event should these hazardous wastes, including solvent residue and detergent residue be placed onto land or into drains, sewers or septic tank systems or be allowed to enter drains, sewers, or watercourses or to contaminate the ground. Recovered liquids may be sent to a permitted reclaimer or incineration facility. Contaminated material, including empty containers, must be disposed of by a permitted waste management facility.
